### **EXAMEN D'UN FILTRE DE COULEUR EN POLYESTER**

#### **RESUME -**

Un échantillon de filtre de couleur en polyester pour l'industrie du théâtre, de la télévision et du cinéma a été testé au B.S. 3944 - 1965 ("filtres de couleur pour l'éclairage de théâtre et autres") et a rempli les conditions exigées. L'échantillon a été également testé au B.S. 2782 ("Méthodes pour tester les plastiques, Méthodes 508 C et 508 D") pour mesurer son caractère inflammable.

#### **1 - INTRODUCTION -**

Cet examen a été autorisé par une lettre de Mr D.A. Holmes en date du 28 Avril 1976 qui faisait suite à une conversation téléphonique avec Mr D.J. Tratford de ces laboratoires.

#### **2 - ECHANTILLONS RECUS -**

Une feuille d'échantillon orange décrite comme filtre de couleur en polyester a été reçue à ces laboratoires le 3 Mai 1976.

Le caractère ininflammable a été estimé selon le BS 3944, Article C. (Essentiellement le BS 2782 - Méthode 508 D avec une interprétation différente des résultats).

### 3.4. - Caractère inflammable -

Il a été déterminé selon le BS - 2782 Méthodes 508 C et 508 D.

## EXAMINATION OF A POLYESTER FILM COLOUR FILTER.

### SUMMARY.

A sample of Polyester film colour filter for the theatrical, television and motion picture industries has been tested to B.S. 3944 : 1965, "Colour Filters for Theatre Lighting and Other Purposes", and found to meet the specification requirements. The sample was also tested to B.S. 2782, "Methods of Testing Plastics", Methods 508C and 508D to assess its flammability.

### 1. INTRODUCTION.

This examination was authorised by a letter from Mr. D.A. Holmes dated 28th April 1976 which followed a telephone conversation between Mr. D.A. Holmes and Mr. D.J. Trafford of these laboratories.

### 2. SAMPLES RECEIVED.

An orange sample sheet described as Polyester film colour filter was received at these laboratories on 3rd May 1976.
